OFFICE MEMORANDUM

Subject: Procedure for providing partial funding support out of GOI-WHO country budget to various institutions/organizations for organizing national/international meetings/seminars/workshops etc.

The undersigned is directed to say that a new policy frame work has been adopted with regard to providing partial funding support out of GOI-WHO country budget to various institutions/organizations for organizing national/international meetings/seminars/workshops etc. All such proposals would, henceforth, be regulated in accordance with the provisions indicated in the following paragraphs.

2. Institutions/organizations listed below will be eligible for grant of the partial support indicated above:

- (i) Central Government Institutions.
- (ii) State Govt. Institutions, if the request comes through the respective State Govt.
- (iii) Autonomous Institutions fully supported by government like PGIMER, Chandigarh, AIIMS, ICMR, NIHF, NIRRH etc.
- (iv) Government Medical Colleges.
- (v) Partner Agencies of Govt., Central or State, with at least 3 years association.
- (vi) Reputed NGOs/IGOs and Professional Organizations/Bodies/Societies.


3. The areas to be covered under this partial funding support will be on subjects relating to Maternal/Child Health, Psychiatry/Mental health, Cancer, CVDs, Diabetes, Strokes, Epilepsy, HIV/AIDS, Blood Safety, Pediatrics, Organ transplant, Trauma care, Climate/Environment related, Rehabilitation, Continuing Medical Education programme, Patient Safety, any kind of emerging public health issues, Public Health Initiatives, Vaccine Quality and efficacy, Application/Introduction of technological solutions including newer vaccines in the public health programme initiative, IHR issues, Strengthening National capacity: NRA assessment, Accreditation and Lab testing, Food Safety and Standards, NCDs, activities relating to AYUSH etc.

4. The quantum of assistance will be provided ranging from Rs.50,000/- to Rs.3.00 lakhs based on the merit/quality etc. (keeping in view the national priority) of the activity being carried out.

All the eligible institutions may submit their proposals for partial funding support out of GOI-WHO funds for organizing seminars/workshops/consultations etc. and for carrying out research activities/surveys etc. to be held during 1st June-31st December, 2010. The proposals to this effect along with all the necessary details in the prescribed format (G-Form: available at website www.whoindia.org) may be submitted to this Ministry latest by 31st May, 2010.
